# **Documentation Guidelines**

# Which type of documentation do you need?

We need two types of documents from you:

- 1. Picture-ID that shows who you are
- 2. Address documentation that shows where you live

# Picture-ID:

What type of documentation do we accept?

#### We need one of the following documents:

- Passport including diplomatic passport, foreign passport, convention passport and service passport
- · Driver's license issued in an EU / EEA / EFTA country including driver's licenses issued in Norway, the Faroe Islands and in Greenland. Danish driver's license for moped and/or tractor is also accepted as long as it's "the new kind" (same physical size as a creditcard).
- · Residence card type C, D and F issued in Denmark (both front and back).
- National ID card issued by the police or tax authorities of a Member State in the Schengen area.
- Danish identity card issued by Borgerservice with picture and full CPR-number visible (this document can be ordered from November 2017). We do not accept "Legitimationskort til unge".
- · Police ID card
- · Military ID card

#### What should I be aware of?:

- The ID must be valid. I.e. the passport may not be expired.
- · It's not permitted to cover or blur information or pictures on the submitted ID.
- · If you do not own a picture-ID, please contact MobilePay Support.

### Address-ID:

What type of documentation do we accept?

We need one of the following documents:

- The yellow "Sundhedskort"
- Det særlige sundhedskort" issued by the Danish authorities
- · Account statement from the bank (sent in e-Boks or via postal service)
- Documents from the tax authorities i.e. your latest tax assessment notice (Årsopgørelse), or your preliminary income assessment (Forskudsopgørelse)
- Documents from the state or government i.e. from the police or the national personal register system
- · Electric-, water- or heating bills sent to your address
- Broadband- or Cable TV bill
- Property lease contract
- · Letter of admission from an educational institution (if the address is specified).
- National ID-card with address from a Schengen-country
- Letter from "udbetaling Danmark"



#### Which information must appear on the document?

- · Your name and address
- · Sender's name and address as well as their logo
- · Date
- · What kind of document it is (account statement, bill, lease, etc.)

#### What else should I be aware of?

- The address document must be no more than 6 months old. Only the yellow "Sundhedskort" can be more than 6 months old.
- · The picture must be clear and visible.
- You may take pictures of paper-documents or of documents on a screen if you have them digitally.
- If you take pictures of documents you have received digitally, please make sure they are readable and that there's no glitter/reflection from the screen.
- · If there's a difference between your name on the documents, please include proper documentation for the name-change (fx marriage certificate or name change certificate)

#### Please note that we do not accept the following documents:

- · Mobilephone bill
- Payslip
- · Bill regarding rent
- · Blue EU Health Insurance Card
- · Payment Services overview (Betalingsserviceoversigt)
- Creditcard
- · Insurance bill regarding car insurance
- · Document from pension company
- · Criminal record
- · Legitimationskort til unge
- · Creditcard
